RECITALS

Upon receipt of the full Settlement Amount, the Subcontractor hereby releases, acquits, and forever discharges the Contractor, its officers, directors, employees, and agents from any and all claims, demands, liabilities, or causes of action arising out of or relating to the invoices specified in Section 1.

4. GOVERNING LAW

This Agreement shall be construed, interpreted, and governed by the laws of the State of _____, without regard to its conflict of law principles.

5. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the Parties concerning the resolution of the disputed invoices and supersedes all prior discussions, negotiations, or draft agreements written or oral.
