2. SCHEDULE OF CAPITAL CONTRIBUTION

3. CAPITAL ACCOUNTS

An individual capital account shall be established and maintained for each Partner. Each Partner's capital account shall be credited with their respective capital contribution and their share of Partnership profits, and debited by their share of Partnership losses and any distributions made to them.

4. PROFIT AND LOSS ALLOCATION

Unless otherwise agreed in writing, the net profits and losses of the Partnership shall be distributed and allocated to the Partners in proportion to their respective Partnership Share percentages as defined in Section 1 of this Agreement.

5. ADDITIONAL CAPITAL CONTRIBUTIONS

If the Partnership requires additional capital to operate or expand, the Partners may, by mutual written agreement, determine the amount of additional capital required and the manner in which it shall be contributed by the Partners.

6. GOVERNING LAW

This Agreement shall be construed, interpreted, and governed by the laws of the State of _____, without

regard to its conflict of law principles.

7. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the Partners regarding capital contributions and supersedes all prior discussions, negotiations, and agreements, whether oral or written, on this matter.
